<u>DISCUSSION</u>: Mr. Anderson, Dr. Jolley, and Commissioner Hausmann provided updates to the Authority on Fulton County and other matters.

<u>PUBLIC COMMENT</u>: Mr. Broadbent announced that the Board would hear public comment. No one appeared for public comment.

OLD BUSINESS:

Final Bond Resolution for PPF Industrial Mason Road, LLC ("Mason Road") (Induced as Lincoln Property Company and Morgan Stanley): Mr. Harrison Sullivan of Seyfarth Shaw LLP appeared in connection with the request for a final bond resolution for the issuance of \$25,000,000 in revenue bonds to finance the development of an approximately 403,000 square foot distribution center to be located near the intersection of South Fulton Parkway and Hunter

Road in the City of Union City. More specific details are described in the Fact Sheet included as part of this item posted on the Authority's website. Upon a motion made by Mr. Broadbent, which was seconded by Mr. Metze and Mr. Beach, the Authority unanimously approved the final bond resolution for Mason Road.

<u>Final Bond Resolution for PPF Industrial Royal South, LLC ("Union 85")</u> (Induced as Lincoln Property Company and Morgan Stanley): Mr. Harrison Sullivan of Seyfarth Shaw LLP appeared in connection with the request for a final bond resolution for the issuance of \$15,280,000 in revenue bonds to finance the development of an approximately 243,540 square foot distribution center located near the intersection of Royal South Parkway and Feldwood Road at the Flat Shoals and Interstate 85 interchange in the City of Union City. More specific details are described in the Fact Sheet included as part of this item posted on the Authority's website. Upon a motion made by Mr. Broadbent, which was seconded by Mr. Beach, the Authority unanimously approved the final bond resolution for Union 85.

Final Bond Resolution for CRP/CHI Fulton Industrial Owner, L.L.C. ("CHI") (Induced as CHI/Acquisitions, L.P.): Mr. Will Pickens of Eversheds Sutherland (US) LLP and Mr. John Bateman of Crow Holdings Industrial appeared in connection with the request for a final bond resolution for the issuance of \$51,000,000 in revenue bonds to finance the development of an industrial park consisting of three buildings totaling approximately 870,000 square feet to be located on the south side of Fulton Industrial Boulevard across from Westgate Parkway in unincorporated Fulton County. More specific details are described in the Fact Sheet included as part of this item posted on the Authority's website. Upon a motion made by Mr. Turpeau, which was seconded by Mr. Lamont, the Authority unanimously approved the final bond resolution for CHI.

Assignment of 715 Peach, LLC Project ("715 Peach") to US VI Peachtree, LLC ("US VI Peachtree"): Ms. Caroline Loftin of King & Spalding LLP appeared in connection with the request for an assignment of 715 Peach to US VI Peachtree. More specific details are described on the Fact Sheet included as part of this item posted on the Authority's website. Upon a motion made by Dr. Jolley, which was seconded by Mr. Beach, the Authority unanimously approved the assignment to US VI Peachtree.

Assignment of Royal South Parkway Investors, LLC Project ("Royal South") to Bixby Land Company ("Bixby Land Company"): Mr. Will Pickens of Eversheds Sutherland (US) LLP and Mr. Jordan Lewis of Greenberg Traurig LLP appeared in connection with the request for an assignment of Royal South to Bixby Land Company. Upon a motion made by Mr. Broadbent, which was seconded by Mr. Turpeau, the Authority unanimously approved the assignment to Bixby Land Company.

Assignment of SRPF A/Graham Road Industrial, L.L.C. Project ("SRPF") to BLC Acquisitions, Inc. ("BLC"): Mr. Woody Vaughan of Holland & Knight LLP appeared in connection with the request for an assignment of SRPF to BLC. Upon a motion made by Mr. Beach, which was seconded by Dr. Jolley, the Authority unanimously approved the assignment to BLC.

NEW BUSINESS:

Letter of Inducement for Red Rock Developments ("Red Rock"): Mr. Jim Woodward of Gray Pannell & Woodward LLP and Mr. John Barker, Jr. of Red Rock appeared in connection with the request for a letter of inducement for the issuance of \$67,000,000 in taxable revenue bonds for the development of two warehouse distribution facilities totaling approximately 1,110,000 square feet and approximately 7,000 square feet of office space to be located on Oakley Industrial Boulevard in the City of Fairburn. More specific details are described in the Fact Sheet included as part of this item posted on the Authority's website. Upon a motion made by Mr. Beach, which was seconded by Mr. Turpeau, the Authority unanimously approved the letter of inducement for Red Rock.

ITEMS FOR APPROVAL:

The Wall That Heals at Veterans Memorial Walk. Mr. Broadbent led discussion and reminded the Authority about the Veterans Memorial Walk in Johns Creek and commended its efforts in bringing The Wall That Heals to Fulton County. Mr. Broadbent recused himself from voting due to a potential conflict. Upon a motion made by the Executive Committee, the Authority unanimously approved, with the exception of Mr. Broadbent and Mr. Tidwell abstaining, an investment of \$10,000 in the Veterans Memorial Walk for The Wall That Heals.

<u>Minutes</u>. The minutes from the Regularly Monthly Meeting held on April 23, 2019 were presented to the Authority for approval. Upon a motion made by Dr. Jolley, which was seconded by Mr. Beach, the Authority unanimously approved the minutes as presented.
