Chairman Shaw called the meeting to order and Dr. Jolley gave the invocation.

COVID-19 UPDATE, GROUND RULES AND PUBLIC COMMENT: Vice Chairman Broadbent explained the Authority would continue to temporarily hold its monthly Board meetings via Zoom videoconference and teleconference in accordance with the Open Meetings Act (O.C.G.A. Section 50-14-1 (g)) in light of the COVID-19 pandemic and the emergency declaration by Governor Brian Kemp. Vice Chairman Broadbent explained the ground rules for participating in the Zoom videoconference and teleconference meeting and announced that the Board would accept public comments in advance of Authority meetings via email. Vice Chairman Broadbent announced that all such comments should be sent to Doris.Coleman@fultoncountyga.gov by 10:00 a.m. on the date of the applicable meeting. Vice Chairman Broadbent further announced that any guests that would like to be recognized as being present for the Regular Meeting should also send an email to Doris.Coleman@fultoncountyga.gov so that their attendance may be formally documented in the minutes. ## **OLD BUSINESS:**

Amendment to the United Way of Metropolitan Atlanta, Inc. Series 2011 Bonds ("United Way"): Mr. Glenn Thomson of Alston & Bird LLP and Ms. Kristen McCollum of United Way appeared in connection with the request for an amendment to the United Way Trust Indenture. Mr. Thomson reminded the Authority that the bonds were issued in 2011 to refund the federally tax-exempt Series 1999 Bonds that were issued by the Authority for the purpose of financing certain office and related facilities for United Way. Mr. Thomson further reminded the Authority that the interest rate on the Series 2011 Bonds was modified in

2016 and 2018 by the Authority. Mr. Thomson explained that the purpose of this amendment would be to modify the interest rate on the Bonds again by converting the interest rate to a new variable rate of 82% of LIBOR plus 1.56% with a cap of 2%. Upon a motion made by Dr. Jolley, which was seconded by Mr. Lamont, the Authority unanimously approved the Amendment for United Way.

Assignment of the PME Oakmont Goodson II, LLC Project (the "PME Oakmont Goodson Project") to LIT Atlanta 85 South II, LLC ("LIT Atlanta 85 South"): Ms. Caroline Loftin of King & Spalding LLP, Mr. Elliot Byers of Clarion Partners and Ms. Maureen Callahan of Troutman Pepper Hamilton Sanders LLP appeared in connection with the request for an assignment of the PME Oakmont Goodson Project to LIT Atlanta 85 South. <u>Letter of Inducement for Middle Street Partners</u>: Mr. Dan McRae and Mr. Harrison Sullivan of Seyfarth Shaw LLP, and Mr. Johnson Bazzel and Mr. Derek Owen of Middle Street Partners appeared in connection with the request to approve a letter of inducement for the issuance of \$73,000,000 in taxable revenue bonds

for the development of a mixed-use project consisting of (i) multifamily residential units, including affordable housing units; (ii) commercial/retail space; and (iii) an underground podium parking deck to be located at 1015 Boulevard SE in the City of Atlanta. More specific details are described in the Fact Sheet included as part of this item posted on the Authority's website. Upon a motion made by Chairman Shaw, which was seconded by Mr. Beach, the Authority, with the exception of Mr. Turpeau, Mr. Lamont and Mr. Tidwell, approved the letter of inducement for Middle Street Partners.

Letter of Inducement for Peachtree Hotel Group: Mr. Dan McRae and Mr. Harrison Sullivan of Seyfarth Shaw LLP, Mr. Shane Moncrief of Ryan, LLC, Mr. John Bealle and Mr. Brian Waldman of Peachtree Hotel Group, and Mr. Gary Mongeon and Mr. Geoff Koski of Bleakly Advisory Groups, Inc. appeared in connection with the request to approve a letter of inducement for the issuance of \$85,500,000 in taxable revenue bonds for the development of an approximately 274-key, 146,700 square foot dual-branded hotel, which will also include accompanying food and beverage, fitness facilities and approximately 4,000 square feet of ground-level retail space to be located at 17<sup>th</sup> Street and Atlantic Drive NW in the City of Atlanta. Upon a motion made by Mr. Beach, which was seconded by Mr. Turpeau, the Authority, with the exception of Mr. Tidwell, approved the letter of inducement for Peachtree Hotel Group.

Letter of Inducement for Reese Meyer at 111 JWD, LLC ("Reese Meyer"): Ms. Allison Dyer and Mr. Woody Vaughan of Holland & Knight LLP, Mr. Chad Meyer and Mr. Jim Meyer of Atlantic Capital Properties, and Mr. Mack Reese of Gateway Ventures Real Estate appeared in connection with the request to approve a letter of inducement for the issuance of \$87,250,000 in taxable revenue bonds for the development of an approximately 25-story high-rise student housing facility, to include an estimated 247 student housing units, including affordable housing units, with an estimated 742 beds and 187 parking spaces and related amenities to be located at 111 John Wesley Dobbs Avenue in the City of Atlanta. Upon a motion made by Chairman Shaw, which was seconded by Mr. Turpeau, the Authority, with the exception of Mr. Tidwell, approved the letter of inducement for Reese Meyer.
