<u>Final Bond Resolution for Lidl US Operations, LLC.</u> Mr. Jim Woodward of Gray Pannell & Woodward LLP, Mr. Aaron Smith and Mr. John Risher of Lidl US Operations, LLC, and Mr. Steve Stroud of Roswell Inc appeared in connection with the request for a final bond resolution for the issuance of \$14,100,000 in taxable revenue bonds for Lidl US Operations, LLC to acquire and redevelop a strip mall and freestanding restaurant building located at 690 Holcomb Bridge Road in the City of Roswell. Upon a motion made by Mr. Beach, which was seconded by Chairman Shaw, the Authority, with the exception of Mr. Tidwell, approved the final bond resolution for Lidl US Operations, LLC.

Final Bond Resolution for 111 JWD Holdings, LLC (Induced as Reese Meyer at 111 JWD, LLC). Mr. Woody Vaughan of Holland & Knight LLP and Mr. Chad Meyer and Mr. Jim Meyer of Atlantic Capital Properties appeared in connection with the request for a final bond resolution for the issuance of \$87,250,000 in taxable revenue bonds for 111 JDW Holdings, LLC to develop an approximately 25-story high-rise student housing facility, to include an estimated 247 student housing units, including affordable housing units, with an estimated 742 beds and 187 parking spaces and related amenities to be located at 111 John Wesley Dobbs Avenue in the City of Atlanta. Ms. Susan Langford of Butler Snow LLP and Ms. Carrie Cornelison of CRN Development, LLC appeared in connection with the request to approve a letter of inducement for the issuance of \$16,000,000 in federally tax-exempt bonds for the development of an approximately three-story affordable senior housing facility consisting of approximately 110 units, including approximately 12 one-bedroom units and 98 two-bedroom units, and approximately 157 parking spaces to be located at 3825 and 3895 Jonesboro Road in the City of South Fulton. Mr. Tom Harrold and Ms. Sarah Fay of Miller & Martin PLLC and Mr. Mark McClendon of Royal Food Service Co., Inc. appeared in connection with the request to approve a letter of inducement for the issuance of \$9,500,000 in taxable revenue bonds for the redevelopment of an existing 75,000 square foot building located at 3600 Zip Industrial Boulevard in the City of Atlanta. Upon a motion made by Mr. Lamont, which was seconded by Chairman Shaw, the Authority unanimously approved the letter of inducement for Royal Fresh Cuts, Inc.

Letter of Inducement for Crescent Communities. Mr. Jim Woodward of Gray Pannell & Woodward LLP and Mr. Phil Carson and Mr. Kyle Brock of Crescent Communities appeared in connection with the request to approve a letter of inducement for the issuance of \$75,000,000 in taxable revenue bonds for the development of an approximately five-story residential and retail facility, including approximately 340 residential units, including affordable housing units, parking and related amenities. Upon a motion made by Chairman Shaw, which was seconded by Mr. Beach, the Authority, with the exceptions of Mr. Lamont and Mr. Tidwell, approved the letter of inducement for Crescent Communities.
