Chairman Turpeau called the meeting to order and Mr. Lamont gave the invocation.

<u>RECOGNITION OF VISITORS</u>: Also present were Mr. Edward Leidelmeijer of Commissioner Hausmann's office, Mr. Al Nash of Parallax Advisory Group, LLC, Mr. Samir Abdullahi of Select Fulton, and Mr. Jim Stevens of On-Call Accounting.

<u>COVID-19 UPDATE</u>, <u>GROUND RULES AND PUBLIC COMMENT</u>: Chairman Turpeau explained the Authority would continue to temporarily hold its monthly Board meetings via Zoom videoconference and teleconference in accordance with the Open Meetings Act (O.C.G.A. Section 50-14-1 (g)) in light of the COVID-19 pandemic and the emergency declaration by Governor Brian Kemp.

Chairman Turpeau explained the ground rules for participating in the Zoom videoconference and teleconference meeting and announced that the Board would accept public comments in advance of Authority meetings via email. Chairman Turpeau announced that all such comments should be sent to <a href="Doris.Coleman@fultoncountyga.gov">Doris.Coleman@fultoncountyga.gov</a> before 10:00 a.m. on the date of the applicable meeting in order for the comments to be distributed to the Board and included in the official minutes of the Authority.

#### **OLD BUSINESS:**

Assignment of BR Vickers Roswell, LLC Project (the "BR Vickers Roswell Project") to 1180 Canton Street Ground Owner LLC ("1180 Canton"). Ms. Caroline Loftin of King & Spalding LLP, Ms. Yosefa Heber of iStar, Mr. Jereme Geller of Waypoint Real Estate, and Mr. Andrew Egan and Mr. Reed Bennett of Kutak Rock LLP appeared in connection with the request to approve an assignment of the BR Vickers Roswell

Project to 1180 Canton. More specific details are described in the Fact Sheet included as part of this item posted on the Authority's website. Upon a motion made by Mr Bacote, which was seconded by Mr. Lamont, the Authority unanimously approved the assignment to 1180 Canton.

Assignment of Palmetto Logistics Industrial Owner, LLC Project (the "Palmetto Logistics Project") to BCIF Palmetto Logistics Center LLC ("BCIF"). Mr. Dan McRae of Seyfarth Shaw LLP and Ms. Kate Kilgore of Black Creek Group appeared in connection with the request to approve an assignment of the Palmetto Logistics Project to BCIF. More specific details are described in the Fact Sheet included as part of this item posted on the Authority's website. Upon a motion made by Dr. Jolley, which was seconded by Mr. Beach, the Authority unanimously approved the assignment to BCIF.

Final Bond Resolution for PAC Worldwide Corporation (Induced as Project Olympus) ("PAC Worldwide"). Ms. Maureen Callahan of Troutman Pepper Hamilton Sanders LLP, Mr. Samir Abdullahi of Select Fulton, Ms. Annie Baxter of CBRE Group, Inc., and Mr. Brendan Savage and Mr. David Peterson of PAC Worldwide appeared in connection with the request for a final bond resolution for the issuance of \$34,675,000 in taxable revenue bonds for the equipping of a new manufacturing plant to be located at 4900 Stonewall Tell Road in the City of Union City. More specific details are described in the Fact Sheet included as part of this item posted on the Authority's website. Upon a motion made by Mr. Lamont, which was seconded by Mr. Broadbent, the Authority unanimously approved the final bond resolution for PAC Worldwide.

<u>Final Bond Resolution for SCP Hapeville Owner, LLC ("SCP Hapeville").</u> Ms. Allison Dyer of Holland & Knight LLP and Mr. Will Casaday and Mr. David Bivens of South City Partners appeared in connection with the request for a final bond resolution for the issuance of \$51,536,000 in taxable revenue bonds for the development of an approximately 284-unit mixed-use apartment community with approximately 5,000 square feet of retail space to be located at 397 North Central Avenue in the City of Hapeville. More specific details are described in the Fact Sheet included as part of this item posted on the Authority's website. Upon a motion made by Mr. Lamont, which was seconded by Mr. Bacote, the Authority unanimously approved the final bond resolution for SCP Hapeville.

### **NEW BUSINESS:**

Letter of Inducement and Final Bond Resolution for AMC Campus Project I, LLC ("AMC"). Mr. Tom Lauth and Mr. Reed Bennett of Kutak Rock LLP, Ms. Fallany Stover of Stover Legal Group LLC and Mr. Michael Montgomery of Atlanta Metropolitan State College appeared in connection with the request to approve a letter of inducement and final bond resolution for the issuance of \$9,500,000 in federally tax-exempt bonds for the refunding of the Series 2011 Bonds, which were previously issued by the Authority for the purposes of financing the construction and equipping of the student activity center located on the campus of Atlanta Metropolitan State College at 1630 Metropolitan Parkway, S.W., in the City of Atlanta. More specific details are described in the Fact Sheet included as part of this item posted on the Authority's website. Upon a motion made by Dr. Jolley, which was seconded by Mr. Lamont, the Authority unanimously approved the letter of inducement and final bond resolution for AMC.

## ITEMS FOR APPROVAL:

Greater North Fulton Chamber of Commerce ("North Fulton Chamber") 2021 Proposal. Vice Chairman Beach provided an introduction on the North Fulton Chamber, including the importance of business recruitment and workforce development, and expressed his support of the proposal (the "Proposal"), a copy of which is attached hereto as "Exhibit A." Ms. Kali Boatright and Mr. Mark Goodman of the North Fulton Chamber appeared in connection with the request to approve the Proposal and provided a detailed presentation that focused on the mission, objectives, initiatives, and partnerships of the North Fulton Chamber. Upon a motion made by Mr. Broadbent, which was seconded by Chairman Emeritus Shaw, the

Authority unanimously approved the \$50,000 investment in the North Fulton Chamber for the 2021 fiscal year, as further outlined in the Proposal.

<u>Minutes</u>. The minutes from the Regular Meeting held on March 23, 2021 and the Special Call Meeting held on March 30, 2021 were presented to the Authority for approval. The Authority unanimously approved the minutes as presented.

## OFFICER REPLACEMENT:

<u>Nomination for Secretary</u>. Chairman Turpeau announced that Dr. Jolley would not be seeking reappointment of his term, which is set to expire on May 31, 2021. Chairman Turpeau and the Members of the Authority recognized Dr. Jolley for his long and impactful service on the Executive Committee and as a Member of the Authority. Chairman Turpeau commended his leadership and expressed appreciation for Dr. Jolley and his service to the citizens of Fulton County.

Chairman Turpeau further announced that in order to prevent disruption and ensure stability of the Authority moving forward, the Executive Committee has nominated Mr. Lamont to serve as Secretary of the Authority, effective June 1, 2021. No other nominations were presented. The Authority voted, with the exception of Mr. Broadbent who was absent for the vote, for Mr. Lamont to be elected as Secretary, effective June 1, 2021.

Chairman Turpeau congratulated Mr. Lamont and provided him with an opportunity to say a few words. Mr. Lamont emphasized Dr. Jolley's impactful leadership and that he would look forward to further serving the Authority and the constituents of Fulton County.

Chairman Turpeau announced that the Authority's next Regular Meeting is scheduled for Tuesday, May 18, 2021 via Zoom videoconference and teleconference. A motion to adjourn the meeting was made by Mr. Lamont, seconded by Mr. Beach, and approved by all members present.
