reated in 1973 by Georgia law and a resolution of the Fulton County
Board of Commissioners as a special unit of government, the mission of the Development Authority of Fulton County is to stimulate diverse, high-quality economic development. It does so primarily by providing taxable and tax-exempt bond financing pursuant to Georgia Development Authorities law.

The Development Authority also funds community based economic development initiatives.

On a sterling reputation for innovation and service excellence, the Development Authority of Fulton County has become the preeminent development authority in the southeastern United States.

The Development Authority of Fulton
County has issued more than \$20
billion in bonds and helped well over
400 businesses and institutions
build, renovate, expand or relocate in
Fulton County. The agency serves
major corporations and institutions.
Projects funded have endowed every-

thing from education, health care and transportation to art and culture.

Cordial professionalism, attention to detail, and **satisfied business partners** are hallmarks of the Development Authority.

The Development Authority's jurisdiction encompasses all of unincorporated Fulton County and its municipalities, including the city of Atlanta. The agency works closely with other state and local economic development organizations as well as with area chambers of commerce. The Authority is a charter member of the Joint Development Authority of Metropolitan Atlanta.

more than 50 total transactions for the agency. This investor activity reflected brisk economic expansion across many market sectors. An estimated **29,175** jobs may be

affected throughout Fulton County, thanks to capital projects funded through this agency. Projects funded were valued at \$2.5 billion—a level not achieved in recent memory. Of note, too, was the diversity of funded areas: technology, education, distribution, mixed-use development, and more.

The Development Authority also considered 24 bond Inducement Resolutions representing more than **\$2 billion** in capital improvement projects within Fulton County and accounting for the creation or retention of 21,777 projected jobs.

The Development Authority welcomed Al Nash as executive director, enhancing the agency's leadership and business recruitment competitiveness. Throughout the year, the DAFC's Georgia Development

> Capital Fund continued to identify projects that might qualify for the New Markets Tax Credit

Program. Certified by the U.S. Treasury as a Community Development

Entity, the fund's establishment allowed the Development Authority to participate in the federal New Markets Tax Credit Program, which offers tax credit opportunities to investors in underserved communities.





THE YEAR IN REVIEW







Continued Expansion

uilding on the momentum of 2014, metro Atlanta, economists predict, is poised for vigorous economic activity in 2015. Expectations that organizations across many market sectors will pursue long-delayed expansion or modernization plans and break ground on new projects paint a promising landscape for the Development Authority of Fulton County. Healthcare, technology, retail, distribution and housing are among

markets cited for possible brisk capital spending—thus generating new opportunities for the DAFC.

The Development Authority of Fulton County will intensely market the diversity of locations and opportunities offered by Fulton County, as well as the financing options and services that have positioned this agency as a leader in quality economic growth.

The Development Authority of Fulton County and Fulton County government, including the Fulton County Board of Commissioners, the County Manager's Office and Fulton County's economic development offices, will continue their longstanding collaborative relationship, creating a viable infrastructure for the agency and strong demand for DAFC services. The DAFC anticipates a solid 2015.

CHARLES SMITH Henry County gain in 2014, the Development Authority of Fulton County collaborated with development authorities in neighboring counties under the auspices of the Joint Development Authority of Metropolitan Atlanta. Member development authorities represented the counties of Clayton, DeKalb, Fulton, Henry, Rockdale, and the return of Douglas. The combined population of the six participating counties represents approximately one-fourth of Georgia's population.

Pursuing a regional approach to economic development, the Joint Development Authority provided a forum for member authorities to address diverse issues—from unified marketing strategies and legislation before the state General Assembly, to local issues affecting regional growth. Topics and presentations in 2014 included, for example, project highlights from the individual development authorities and a proposal for educational outreach to elected officials about the Joint Authority's role in advancing regional growth.

The Joint Development Authority of Fulton County's participation in the Joint Development Authority allowed each company locating within its jurisdiction to earn a state tax credit of \$2,500 for each qualified new job, over a five-year period.

The Joint Development Authority's Board of Directors met quarterly at sites hosted by member development authorities. Robert J. Shaw, chairman of the Development Authority of Fulton County, served as chairman of the Joint Authority in 2014.
