2017 year in review

2017 brought significant market expansion across a multitude of industries as the area's economy continued to thrive. The deals closed in 2017 resulted in the creation or retention of over 20,000 jobs, and the investment of more than \$1.76 billion in Fulton County. In addition, catalytic projects from recent years have continued to drive economic development, creating a "halo effect" of sequential business activity in 2017.

The capital investments in these DAFC financed projects fully support the DAFC's mission to promote economic development in Fulton County. Successful project announcements, including the new Sonoco packaging and display facility in the City of Fairburn, Sysco food operations expansion in Atlanta, and new logistics park in the City of Palmetto, are anticipated to bring a steady flow of jobs and revenue to the community, as well as revitalize older and/ or unused assets into exciting new opportunities. Through these successful projects and collaboration with our partners, DAFC has helped make Fulton County the thriving business community it is today. With continued focus, commitment, and partnership, we are confident the success of our work will beget future investment to the county.

Community organizations to whom we owe many thanks for their collaboration and support include the Joint Development Authority of Metropolitan Atlanta; Georgia Chamber of Commerce; the Metro Atlanta Chamber; and the International Economic Development Council, which certifies economic development professionals worldwide. The Development Authority works closely with the Georgia Economic Developers Association and the Georgia Department of Economic Development to prosper our community by bringing new businesses and industries to Fulton County.



Bond inducements

The Development Authority in 2017, approved 29 bond inducement resolutions, representing more than \$2.3 billion in potential capital improvement projects in Fulton County and accounting for the creation or retention of a projected 20,937 jobs.

By comparison, the Development Authority's 44 inducement resolutions of 2016 totaled more than \$3.8 billion in potential capital investment, creating or retaining a projected 32,210 jobs. The 34 inducement resolutions in 2015 reflected over \$2.6 billion in potential projects, accounting for the creation or retention of a projected 19,821 jobs.

Project financing obtained through bonds issued in 2017 by the Development Authority totaled \$1.76 billion, creating or retaining a projected 20,967 temporary or permanent jobs within Fulton County. By comparison, bonds issued by the Development Authority in 2016 totaled \$2.0 billion, accounting for approximately 14,041 temporary or permanent jobs within Fulton County. For 2015, the Development Authority issued bonds valued at \$2.6 billion, and created or retained a projected 13,633 jobs.

Economic impact results for 2017

Property tax incentives were provided by the DAFC with the requirement that new economic activity result from the incentive.


In 2017, there were 62 projects actively receiving a property tax incentive. At the time these projects received approval for their property tax incentives, they planned to make capital investments of \$5.3 billion and create or retain 29,380 jobs in Fulton County.

Construction-related benefits

Projects receiving a property tax incentive in 2017 planned to spend \$5.3 billion in new buildings, renovations of existing buildings, and new equipment and machinery. Jobs were created when the company made the investment, which could have been at any point in the past 10 years. The average annual employment impact due to construction activity is estimated to be 4,599 jobs. Workers in construction and other industries that benefited from the capital investments received \$3.3 billion in labor income over the past 10 years for an average compensation of \$71,366 per worker.


GASB 77 results

GASB 77 overview

In April 2015, the Governmental Accounting Standards Board (GASB) issued Statement No. 77, which requires all state and local governments to disclose tax revenue foregone associated with a government's tax incentive agreements for each annual reporting period. The DAFC has been a leader in complying with this new requirement, collaborating with the Fulton County's Tax Assessor's Office and Finance Division, school districts, and local municipalities in the county.

County property tax impact

The 62 projects that received a property tax incentive from Fulton County would have only paid \$4.0 million in property taxes in 2017 had they not made new investments. After making new investments, these projects contributed \$18 million in real and personal property taxes for the Fulton County government. Fulton County then provided an incentive of \$6.6 million resulting in \$15.5 million in total real and personal property taxes in 2017 and a total net benefit of \$11.5 million.



\$15.5m* in 2017 Real and personal property taxes for 62 projects



Fulton County tax benefits in 2017

Economic activity associated with active incentive projects supports tax revenue for Fulton County. The total county tax benefit due to active incentive projects is estimated to have been \$31.5 million in 2017, with projects contributing \$30.2 million in property and sales taxes.




Strategic alliances
