DAFC Launches Small Business Loan Program To Help Entrepreneurs Navigate Covid-19 Crisis

In addition, many existing businesses are hurting, particularly our small and minority businesses.

The DAFC board has been especially mindful of our neighboring communities and decided to create a loan program targeting the County's struggling small businesses. The program is designed to help these businesses, many of which are minority and female owned, survive the Covid-19 shutdown with the hope of providing meaningful assistance for long-term business operations. Our goal is to help these small businesses access the capital that may not otherwise be available while also connecting them to resources that will lead to their success. The program, which is further outlined below, is off to a great start and is achieving our objectives.

When crisis occurs, it is important that our institutions be creative, nimble and respond to the true needs of its constituents. The DAFC Business Contingency Loan Program is an innovative solution that is helping Fulton County's small businesses survive a challenge not of their own making.

Generally, the DAFC is viewed as an agency primarily focused on recruiting new and expanding business opportunities to Fulton communities. However, in today's unusual environment, the Authority's priorities include extending a lifeline to as many local businesses as possible due to the closures associated with the Covid-19 pandemic.

While the Federal CARES Act provided paycheck protection funds for some businesses, many businesses still face funding gaps. So, DAFC launched the Business Contingency Loan Program to assist small business in all 17 Fulton municipalities with business continuity financing.

The Authority contracted with Access to Capital for Entrepreneurs (ACE) to administer a \$6 million loan program to County-based businesses. ACE, a 501(c)3 nonprofit community development financial institution, provides loans and business consulting services in Metro Atlanta and North Georgia.

Since 2000, ACE has loaned more than \$80 million to more than 1,000 Georgia entrepreneurs. DAFC's emergency loan program features four percent interest over 36 months with three months deferred principal and interest, then three months interest only followed by 30 months of P&I payments. Through mid-May, the program closed 47 loans with 57 percent going to entrepreneurs of color and 47 percent going to female-owned businesses (many of whom were also women of color).

These 47 loans dispersed \$1.5 million, with \$1,015,000 to entrepreneurs of color or women (68 percent) and \$485,000 to non-minority men (32 percent).

Applicants applied online through a portal designated as the Development Authority of Fulton County Contingency Loan Program. Minimal documentation was required, generally 2019 year-end financial statements or tax returns.

In addition to loans, the program provided business coaching and support to all borrowers through Morehouse College, UGA Small Business Development Centers, Georgia State SBDC and ACE Women's Business Center.

These are just a few steps DAFC is taking in our ongoing journey to bring about meaningful progress and results and we welcome you to share your ideas with us as we move forward together.

While the challenges we are facing are unprecedented, we are proud of the efforts our community has taken and we look forward to future success in our County.
